The minutes of the meeting held on 1.1/11/2021 are as follows:

The Institute level SSIP committee meeting was started with the permission of Dr H N Shah, Director of institute. Prof Mrugesh Khatri, Prof Jyotin Kateshia and Prof Sejal Bhavsar discussed the procedure for the project allocation and screening.

Agenda 1:- The project source after the revision of GTU syllabus in BE Sem-8.

The Director Sir informed that the final year students have option of internship. Hence, the students may go for internship or project. He added that the DE projects need to nurture for nominating them for SSIP, IPR, IIC support. In addition, the projects must be mentored in such a way that they may take benefit at least under one cell.

Agenda 2:- The procedure to allocate the projects to UG and PG student.

It was discussed that the majority students failed in selecting the potential projects. So, the Director Sir proposed the structure for project allocation. He informed them faculties must propose the titles of their expertise. The students should propose their own project title or select from the faculty nominated titles.



Agenda 3:- Nomination of best projects for SSIP/IIC/IPR/NISP/Hackathon for nurture them for state or national level competitions.

The Director sir instructed that all projects of DE-IIA must be unique and the projects must have potential to obtain benefit under any of following vertical: under SSIP, IIC, Project Expo, Hackathon, IPR, IQAC etc. The best projects of DE (Sem 5-6) & Project (Sem 7-8) should be nominated by department DE coordinator & project coordinator to obtain benefit of different cells. The list of DE-II (Sem 5-6) & Project (Sem 7-8) must be kept in record by respective department coordinators & shared with SSIP Cell with evaluation / review marks for further procedure. He also added that all faculty supervisors must guide and motivate at least one student team under him/her.

Actions taken report for the meeting of SSIP scheduled on 11/11/2021

- 1. The standard procedure for project finalizing (Sem 5 & 7) have been prepared as follows:
 - a. The project titles must be collected from all faculty member in the month of April and October to offer the same in upcoming semester starting from June (Odd) and December (Even).
 - b. The google form (common for all department) for project selection should be shared with students before commencement of semester and 15-20 days' time period must be given to students for finalizing their projects.
 - c. The students have following options for project selection:
 - i. Their own project title is allowed, if supervisor evaluate it and recommend.
 - ii. Industry Defined Problem statements.
 - iii. From the list of project titles proposed by faculties.
- 2. The various cell benefits were finalized as follows:
 - a. SSIP Cell: Mentoring support from institute faculties and industry experts. Financial support for POC/Prototype up to Rs 2 lac.
 - b. IIC Cell / i-Hub: Financial support above Rs 2 lac for POC/Prototype.
 - c. IPR Cell: The top 3 to 5 teams of each department will proceed for IP filling with financial support and patent attorney.
 - d. Hackathon Cell: Best projects will get nominated for hackathon / project expo participation.
 - e. IQAC Cell: For publication, the teams may apply for travel grant with support of IQAC Cell.
