
Event Overview: - The expert session was attended by 52 faculties and staff members of different institute of Gandhinagar University. The session started from 1:30 pm to 03:00 pm with introduction of the expert by Prof. Ruchir Parikh. Dr. Ravinder has explained important parameters for NAAC, NBA Accreditation and NIRF ranking and difference between them by giving examples. He demonstrated the importance and point distribution of each parameter thoroughly and step by step procedure to apply for accreditation. He advised from his experience that if any college/University wants to apply for accreditation they have to start the preparation before 8-10 months with more than 30000 documents. Outcome: - faculties had understand the importance of accreditation and different parameters of accredited bodies.






Dr Ravinder presenting criteria for accreditation
