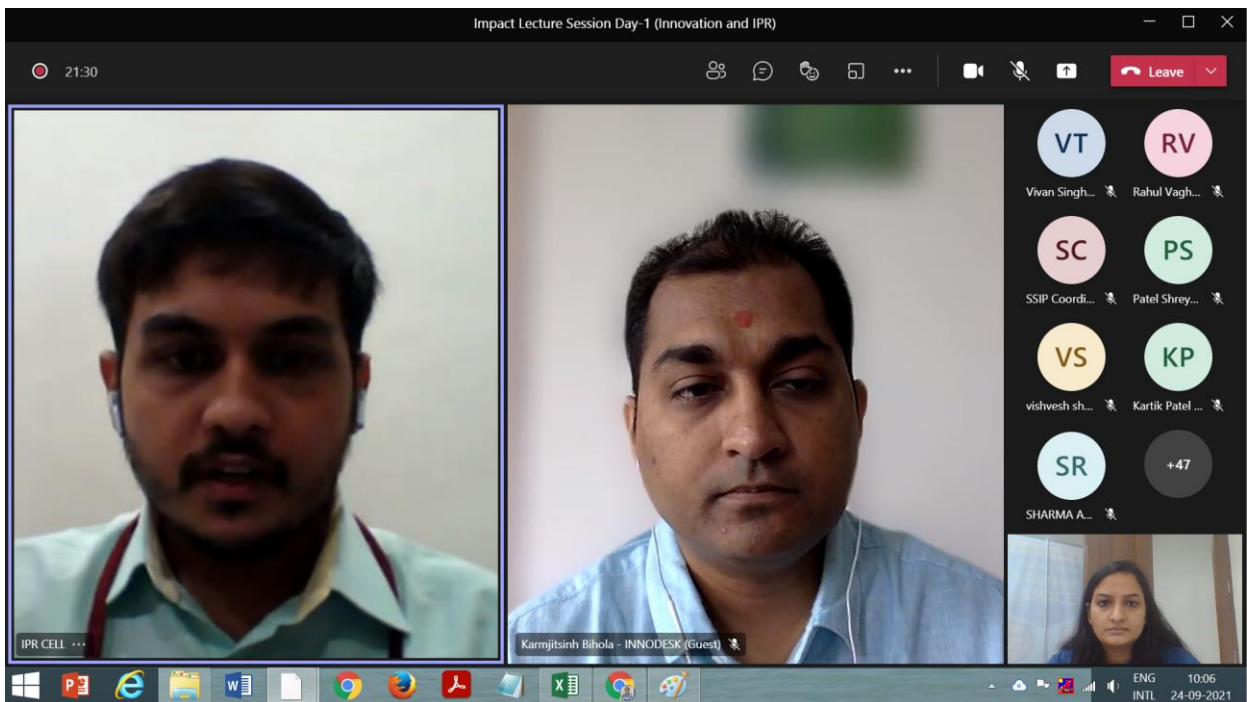
Introduction:

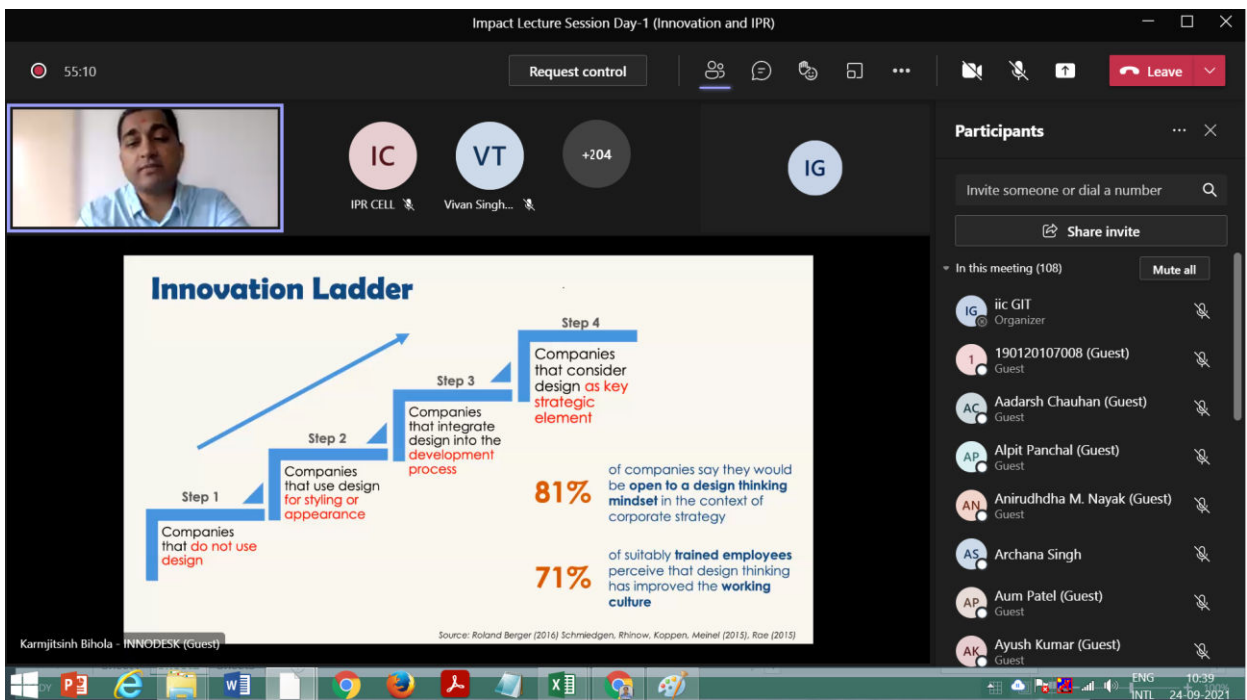

Day-1

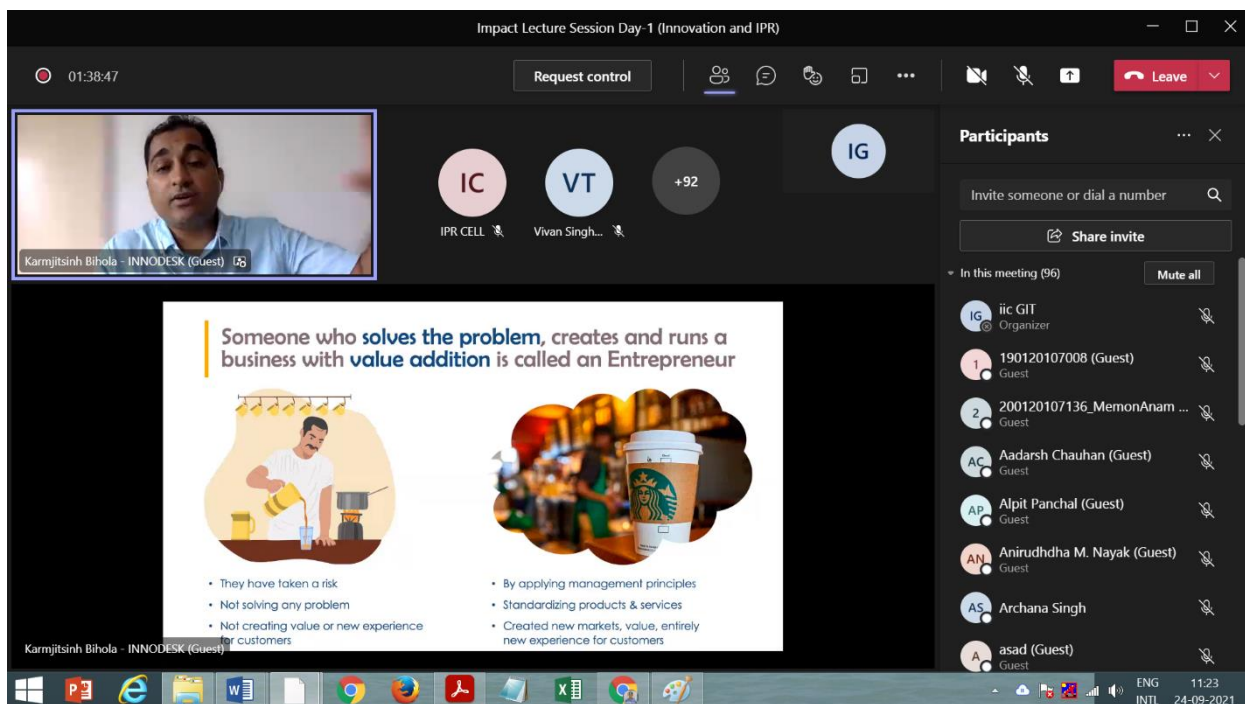

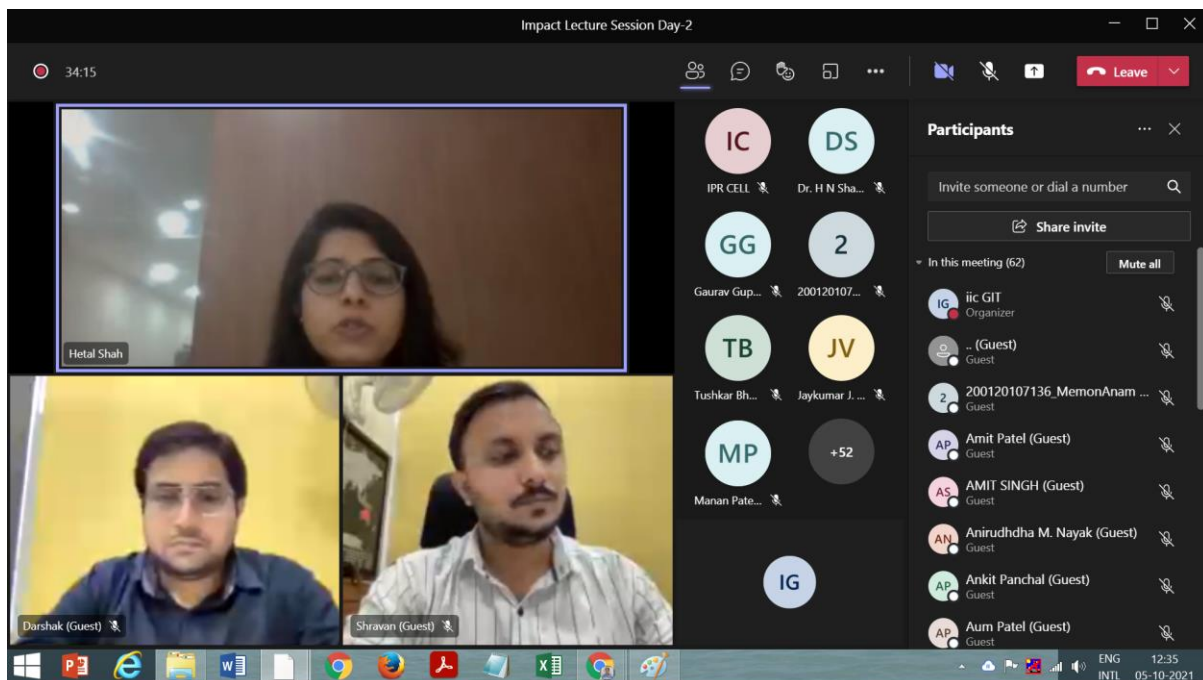
Introduction:

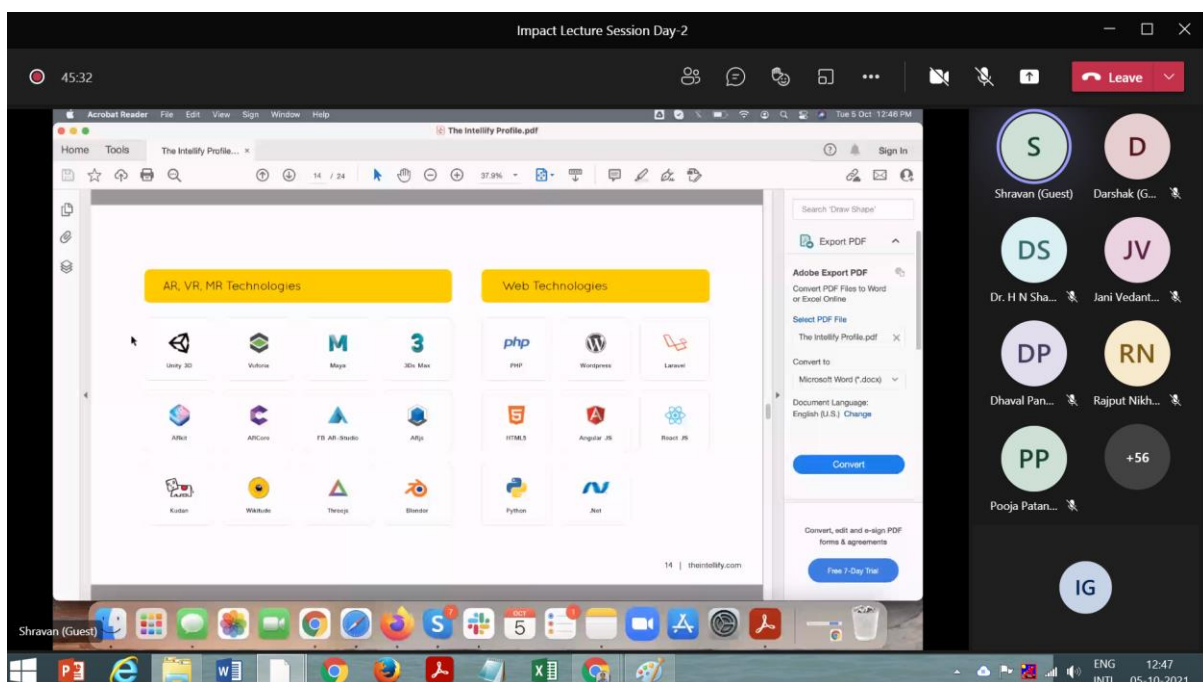

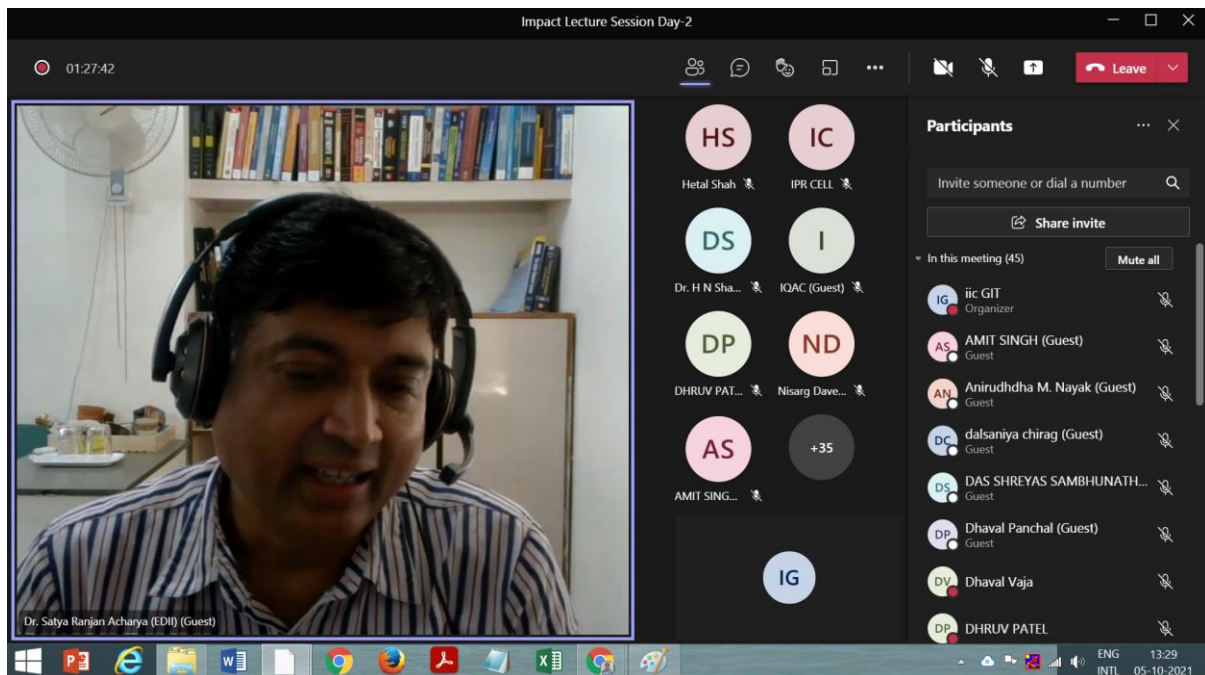

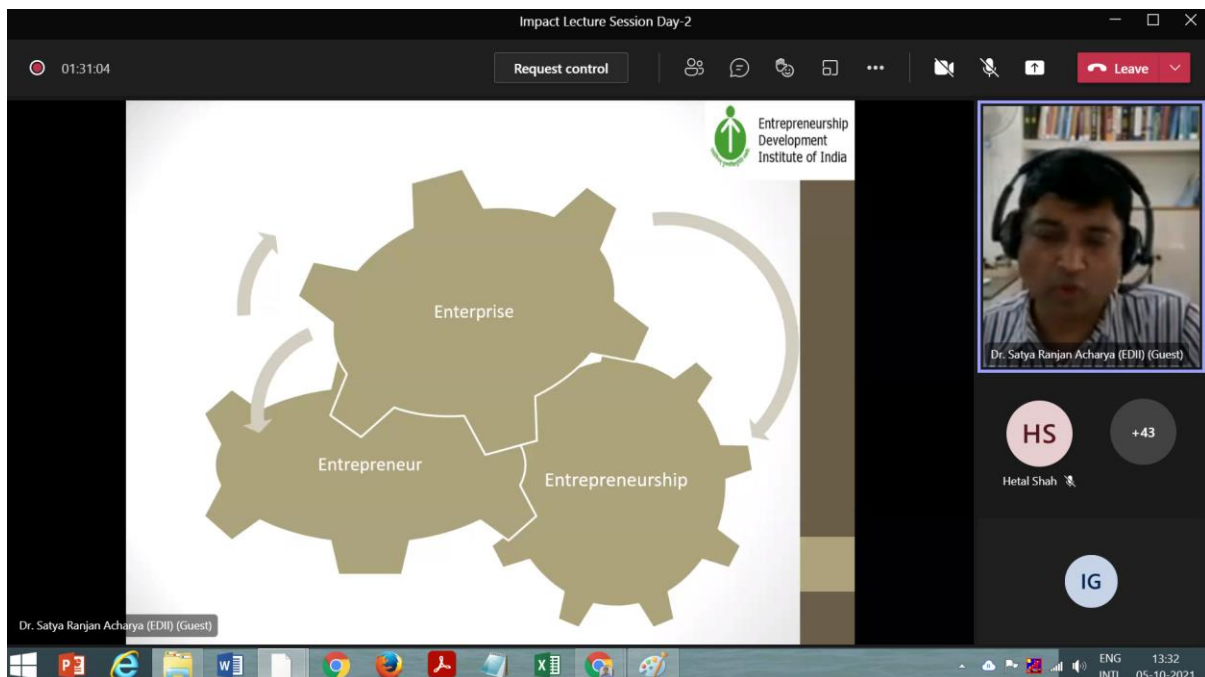
